**Preamble:**

- Functional Heads and Company Executives are invited at Board or Committee Meetings, as and when required, to provide a platform for interaction of Independent Director’s with them and also to enable Independent Director’s to better understand business and operations of the Company.

- Each member of the board, including the Independent Director’s, have been given complete access to any information relating to the Company, whenever they so request.
